ATC Tipping Competition

General Terms and Conditions

1. The promoter of the ATC Tipping Competition is the Australian Turf Club Limited (ABN 81 148 157 288) (Promoter). Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61296638400.
2. Rules on how to enter the ATC Tipping Competition form part of these General Terms and Conditions (and schedule). By entering the ATC Tipping Competition, entrants agree to be bound by these General Terms.
3. The ATC Tipping Competition will run as five separate events across the dates of the 17th and 24th November 2018 and the 1st, 8th and 15th December 2018
4. Entry is open to anyone who has downloaded the ATC Wagering App and registered their details within it. Entrants may enter only once per person per day. If more than one entry is received from an entrant per day, only the first valid entry that day will be eligible.
5. There is no cost to enter once the ATC Wagering App is downloaded.
6. No ATC employee, official or spouse/partner may enter the ATC Tipping Competition.
7. This competition is a game of skill requiring entrants to finish with the highest possible total points balance based on the competition rules.
8. This event is restricted to over 18's only and all contestants will be asked to provide proof of identification before claiming any prize.
9. Total prizemoney for the ATC Tipping Competition is \$2,500, with each of the five days being worth \$500. This will be paid to the winner/s of each day's competition only.
10. No individual prize exceeds \$1,000 and total value of prizes do not exceed \$100,000
11. The ATC Tipping Competition will commence from 7am on each of Saturday 17th and 24th November 2018 and Saturday the 1st, 8th and 15th December 2018. On each day, the entries will close immediately prior to Race 5 at Rosehill Gardens or Royal Randwick. Any entries sent after this time will not be eligible.
12. On any one day, entrants will need to tip a runner in each of the four nominated races to enter that days competition.
19. Each tip will be regarded as having had a \$10 win bet and a \$10 place bet put on it through the NSW TAB pari-mutuel system. Results will be based on the Official Dividends from NSW TAB.
20. Once results of each race are determined, successful tips will have their total returns (as if betting) converted to points. This will include the \$10 'stake'. When all the points balances are calculated, the highest points holder at the end of the competition will be determined the winner.
21. Should there be more than one entrant finishing with the highest total, the prizemoney will be divided by the number of tied entrants and evenly distributed.
22. Winner/s will be contacted using the phone number provided when downloading the ATC Wagering App.

23. Prizemoney will be paid in cash on the day, or by cheque or EFT if this option is unable to be performed.

24. Should the races at Rosehill Gardens or Royal Randwick be abandoned or postponed at any time prior to completion of the four races scheduled as part of the ATC Tipping Competition, all entries will be considered null and void.

25. If for any reason the Challenge is not capable of running as planned (including, without limitation, due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the ATC which corrupt or affect the administration, security, fairness, integrity or proper conduct of this promotion), the ATC will not be liable for any failure to perform or delay in performing its obligations and reserves the right (subject to any written directions given under applicable law) to cancel,

terminate, modify or suspend the Challenge. The ATC is not responsible for any malfunction, delay or traffic congestion on any telephone network or line, computer on-line system, servers or providers, computer equipment, software, or website.

26. The ATC reserves the right to alter any of the above rules and conditions should it deem necessary. Their decision will be final.

27. If any entrants do not adhere to any of these rules and conditions this may lead to disqualification.
